Pensacola Camellia Club Board Meeting March 6, 2012

Present: Pres. Davy, Past Pres. Fosha, 1st VP Vogelsang,2nd VP Lyford, 3rd VP Kerr, Secy. Vickers, Treas. T. Morris, Board members: Bennett, Bruno, Engie, Hooton, Kaufke.

Also present, Sandra Sherman, newsletter editor and Joan Blanchard.

Absent: Christi Hankins, board member; and Roger Vinson, Foundation Chair (both out of town)

President Davy called meeting to order at 6:00 p.m.

OLD BUSINESS

Banquet: Lyford reported 42 attendees and a satisfactory event. Some discussion ensued about next year's event re cost and location. Can be subject for summer workshop.

Community Camellia Show:

Vogelsang expressed general satisfaction with the show. Not as many blooms or entries than last year but visitors were numerous and all plants were sold. Some disappointment was expressed that not many of our novice members entered blooms as hoped. Compliments for Jerri and Jim Smith—she did wonderful job with refreshments!

December Camellia Show:

Anticipate move to First Baptist for 2012 and 2013 show. Hooton reported that advantages—larger exhibit space, separate and larger set-up area, increased parking space and total cost \$300- an economic saving. Not sure about number of tables available, but with the economic savings, needed tables can be rented. T. Morris to cancel with First United Methodist

Church and ask about billing for last year's judges luncheon as we can't find documentation that this was paid. (What about cancellation with Sanders Beach location for 12/13? Has that been accomplished?)

REPORTS:

Treasurer's Report: Current balance \$10, 579.41. Vogelsang reviewed the income/expense print-out explaining, especially to new board members, how to interpret the details. It is expected that we will finish the fiscal year (new fiscal year starts in August) slightly ahead of projected budget. Foundation: No report as Vinson out of town.

Membership: Judy Kerr reported current membership at 218. Twenty-three members were joined at the recent Garden Tours and Community Camellia Show. Forty-two persons were dropped after extensive campaign-letters, phone calls and e-mails to retain these members. Letter from Mrs. Jack Wetherell of Bellevue, Nebraska indicating that Jack is now 91 and in failing health. Unlikely that they will be able to move back to Florida. In view of Mr. Wetherell's longtime membership and contributions to the club, therefore, Moved, Seconded Passed: UNANIMOUS

VOTE TO RETAIN MR. WETHERELL AS HONORARY MEMBER. Ms.

Kerr will write Mr. Wetherell of board action.

Program: for March membership meeting, Lyford reported that Davy and Bennett will present program on pruning, unusual forms of grafting, brief discussion of air-layering and answer questions about camellia care.

For April meeting, Lyford will ask Larry Morris to present program on camellia pests, diseases and summer care.

Newsletter: President Davy thanked Sandra for her continuing work on the newsletter. (Applause from the attendees.) She reported that US Postal rates are due to rise again. She is mailing about 40 newsletters and because of ink costs, photos will be in black and white—another inducement to get newsletter on-line.

Website: Lyford reported that we average about 50-70 visitors/week and some visit several pages on the site. Occasionally there are foreign visitors as well. Anne Hooton, Dick's daughter, contributes to PCC Facebook page.

Shade House and Plant Sales:

Hooton reported that this year's plant sales had depleted all/most of the ones available—a desirable position to be in. Some ones held over because not quite mature, have been moved to the "ready for next sale" side. NEXT SHADE HOUSE WORK DAY WILL BE SATURDAY MARCH 17. WORKERS PLEASE BRING A HOE FOR WEEDING.

NEW BUSINESS

Air-layering project: Joan Blanchard volunteered to take on this year's project.

discussed ongoing plan to convert garden cover from grass to mulch. Projected cost \$5,000. With \$1,000 grant from Kugelman Foundation and \$1,500 from UWF Retired Employees Association, we still need \$2,500 to complete. After discussion, it was decided that a letter would go to all members requesting donation. Also discussed was "adopt-a-plant"

plan. Details of adopt-a-plant will be refined by Vogelsang and others to present at the upcoming membership meeting.

Camellias in urgent need of adoption

By Skip Vogelsang Our camellia garden at UWF now has 153 varieties planted and morewill be added over the year ahead. Many are very rare and endangered Pensacola varieties. For example there are only three known specimens of Lolita anywhere in the world. Presently we are spending more time caring for the grass at the garden than the camellias. To correct that we need to convert the garden site from grass to a natural mulched base that will allow us to focus upon the camellias. The cost of this project is about \$5,000 and \$2,500 has already been raised from a Kugelman Foundation grant and funds from the UWF Retired Employee Assoc. So we just need \$2,500 more.

Most all of the camellias at UWF are very young and defenseless. They need the love and attention and support of caring adults to help them grow up to be strong, healthy and productive members of the camellia society.

Won't you please find it in your heart to adopt one of these poor adolescent camellias and make their formative years a little better? Let their young roots grow strong under a protective layer of moist mulch and pine straw instead of fearing for their lives each year when the dangerous blades of the mowers come so close to their fragile little trunks.

We ask for a minimum of \$25 for each camellia adoption (but we hope you will consider more).
