# MINUTES PCC BOARD OCTOBER 5, 2011-Tryon Branch Library

Present were: Charles Fosha, Sandra Sherman, Judy Kerr, Joan Blanchard, Carol Comber, Dick Hooton, Al Jeppesen, Bill Lyford, Gabriel "Ole" Olsen, Norman Vickers, and Skip Vogelsang.

Absent: Bruce Musselman, Barbara Angello, Thekla Morris, and Dennis Kohli. (Musselman had meeting conflict; Angello and Morris are convalescing and Kohli out of town on FEMA assignment)

Meeting was called to order at 6:10 by President Fosha. He welcomed Al Jeppesen to the board. Jeppesen, previously served on the board, was appointed to fill the vacant position of LeAnna Brennan who is on teaching assignment in China for a year.

#### **OLD BUSINESS**

Plant Sale: Sandra Sherman reported that the brochure for the camellia show had been read/critiqued by several and has been printed. She will cater the judges' dinner to be held at Vinson home. Moved, seconded, passed: COST WILL BE \$25 FOR ATTENDEES. Out-of-town judges and spouses, of course, will be gratis. Hooton will arrange to

secure wine & beer. Because of space limitations, guest list will be limited to 40 persons and only board members, key personnel, workers and their spouses will be eligible to attend.

Discussion ensued about the smaller foyer room at Wright Place. Fosha reported that he had arranged with First Methodist/Wright Place for rental of that room. Subsequent review of minutes from the June 2011 planning meeting clearly stated that club was to rent the room and that the cost would be \$300.

**Budget:** Vogelsang reported that he had worked on projected budget—passed this to attendees and explained the details. It was also explained that expenses to club should be itemized and then when approved, check would be written by treasurer. Bill Lyford is working with T. Morris on this aspect. Monthly report will be presented to the board meetings. Subsequent to the meeting, voucher forms were e-mailed to board members.

#### **REPORTS**

**Finance:** Lyford reported in absence of T. Morris, that bank balance currently is \$5,235.25. **Membership:** Judy Kerr reported that addition of four new members brings membership to 211.

Members not renewing through December will be dropped. Retention efforts are in place. Newsletter: Sandra Sherman asks that information for newsletter be in her hands by Friday 10-7. Copies of UWF's student newspaper, Voyager, were passed out. The 9/28/2011 issue has a front page article about the UWF Camellia Garden.

**PR**: Vickers reported that press releases had been sent. **UWF Camellia Garden**: Skip updates us on progress.

Plant Sales/ Shade House:
Hooton gave update about
current status. He and
Vogelsang will go to Fairhope
tomorrow to pick up plants at
Bobby Green's. There was a
new variety/scarce/ valuable
plant variety Sara Paul obtained
at the recent Gulf Coast
Camellia Society. It was
decided to sell at silent auction.

**February Banquet**: Lyford presented information. Decision was made that charge for banquet would be \$30. He passed around menu options and decision was made by popular vote.

Business concluded and meeting adjourned at 7:10 p.m.
