A Camellia Calendar of Love

John Edwards (1915-2007), a Pensacola native and member of the Pensacola Camellia Club since 1937, left the growers of camellias a Camellia Calendar that represents 'tender and loving care' attitude. John loved camellias and expressed that love through his comment, "You can be down, you can be ill, but just go out there (his greenhouse) and see what God has created. It's marvelous! I'd say this is the best therapy that ever was."

- **January** Water well before freeze if extremely dry. Plant new varieties; transplant older plants and complete potting program. Continue 'gibbing' if you have suitable buds. Compete in, and visit, Camellia Shows.
- **February** Time to begin your grafting program. Prune dead wood. Pickup and destroy fallen blooms.* Compete in, and visit, Camellia Shows.
- **March** Complete grafting program. Fertilize. Complete your pruning program and cut back large plants. Pickup and destroy fallen blooms.* Compete in, and visit, Camellia Shows.
- **April** Complete fertilization. Time to propagate by air layering plants. Spray (after danger of frost). Pickup and destroy fallen blooms.*
- **May** Complete spraying of plants.
- **June** Water if too dry.
- **July** Water if too dry. Begin propagation from cuttings. Light application of fertilizer (low in nitrogen content). Summer grafting.
- **August** Water if too dry. Apply light application of fertilizer. Complete your cutting propagation.
- **September** Plant camellia seeds. Air layer plants should be ready to pot. Spray if needed. Begin disbudding and 'gibbing' programs.
- October Complete disbudding of plants, and continue to pot air layer plants. Mulch for winter months. Continue 'gibbing' program.
- **November** Water if too dry. Plant new varieties. Transplant or repot plants. Continue 'gibbing' program.
- **December** Water if too dry, especially before a freeze. Continue planting program. Continue 'gibbing' program. Pickup and destroy fallen blooms.*

The attention given to your plants expresses your love for them.

- *(Fallen blooms create spores that cause petal blight.)

PCC BOARD MEETING MINUTES TRYON LIBRARY 6:00 PM. TUESDAY SEPTEMBER 3

Called to order at 6:00 p.m. by Pres. Paul Bruno- welcome all. Introduce Winkie Rhea as understudy for Secretary Vickers. Explained the newsletter editor Mark Erwin unable to attend because of business commitment.

REPORTS:

- Review Picnic at John Davy's home: Bruno expressed thanks for wonderful hospitality at the Davy Home. All agreed. It is hoped that picnic can be at Davy's home again next May.
- Review August dinner meeting: Bruno & others--64 attendees. Vinson, Vogelsang & Hooton gave overviews of convention plans, tours, plant sales, camellia show. Bruno reported that wait-staff was helpful and tips by some of our members were light. He gave extra \$40 tip to staff from evening receipts. Motion made to reimburse Bruno \$40 by PCC. MSP: unanimous approval.
- Treasurer's report: T. Morris, Lyford and Vogelsang. See attached reports. We were over budget, in part related to \$600 spent last year for vests for camellia show. It was noted that these will be used for several years, so that if amortized over several year period, it would have reflected in less of loss. Later in the meeting several budgetary questions arose and are included here for clarity. Hooton said that because we now have access to land on which shade house occupies, there will be expenses related to power, water, and upkeep. Perhaps additional storage space needs be built to accommodate club's supplies related to the Camellia show. Vogelsang reported that riding mower and standard power mowers have been moved from UWF Camellia Garden to Seville Power for servicing before being moved to the Shade House area. Also later in the meeting, Sherman brought up the question of expenses of our truck and whether leasing on an as-needed basis would be less expensive. Bruno asked Sherman and Vogelsang to confer and bring facts and recommendations to next board meeting.
- **Membership:** Christi Hankins reported that we now have 245 members, not all paid up for this year, yet. Bruno urged efforts to recruit new members, especially in this ACS Convention/Show year.
- Foundation: Roger Vinson reported balance at \$59, 922.

- **Program:** Sandra Sherman-As detailed at summer workshop and at this meeting. Sept- Promote ACS convention- gibbing, disbudding by Hooton and Vogelsang. Planting seed-John Davy. Also camellia photo display by Vogelsang. (Sherman reported her power-point project was broken so other arrangements need be made.) Oct. harvesting air layers. Vogelsang and Hooton talk about camellia show. Emphasize new camellia varieties. Nov- name nominating committee. Skip Vogelsang presents entire program devoted to Camellia Show. Dec: First Tuesday 12/3. Read nominating committee report. Discuss last-minute planning and details for convention and camellia show. T. Morris has reserved Garden Center for this first Tuesday meeting.
- **Newsletter:** In Mark Erwin's absence. Bruno said he'd be working with Mark for a quality product.
- **Website:** Bill Lyford reported that Aeiko Mitchell, website maven, is doing a good job fulfilling our requests. Sherman brought up fact that photo and names of officers of PCC on ACS website are several years old. Lyford will contact ACS about updating PCC section on ACS website.
- **PR:** Norman Vickers reported that we've had good press so far. Idea for stickers for rear window of automobiles would be great promotion for our ACS Convention/Show. Vote authorizing expenditure not to exceed \$200 was made. He emphasized need details of speakers for ACS convention for press. Can't get press release out until we have some specific details!
- **UWF Garden:** Skip Vogelsang reported that we'd need workday Friday & Sat Oct 4-5, 9-11 a.m. should do it. Would need additional help in gibbing at UWF Garden. Has sprayed for dollar-weed and it seems to be effective.
- Plant sales-Levin project: Dick Hooton reported that there would need to be a work-day at the Shade house at time TBA. Some discussion about Mr. Levin's naming a camellia after his late wife. Hooton, Bruno & Gene Rosenbaum to get together with Mr. Levin.

OLD BUSINESS:

• PLANS FOR UPCOMING ACS CONVENTION AND NATIONAL CAMELLIA SHOW: R. Vinson, Vogelsang, Hooton & others discussed judges dinner, Friday night, for those judges & spouses who came to judge show but didn't register for ACS convention. Moved, seconded, passed: offer 50% discount to judges & spouses who don't register for ACS convention. Passed motion to invite Mayor Hayward to greet judges and workers at 10:15 a.m. at ACS Camellia Show. Hooton and Vinson to coordinate with mayor's office.

NEW BUSINESS:

• Announce Gulf Coast Camellia Society mtg. Mon-Tues Oct14-16-Spanish Fort, AL Congratulations Gabriel "Ole" Olsen and Carol Comber-newly registered camellias. Vickers will work up a press release emphasizing new camellia registrations, including those of Hooton, Davy and Vogelsang. Also to mention upcoming ACS Convention & Show.

BRIEF COMMENTS: ideas, suggestions, topics for next meeting "For the good of PCC" Various comments: emphasize more Pensacola variety camellias for our members-Joan Blanchard. Sherman: PCC membership in Friends of the Gardens of NW FL. Moved, seconded, passed--\$50 for organizational membership. Other comments and action were reported within the text above.

Adjourned at 7:20 p.m.

Now, thanks in large part to the Foundation's financial support, we no longer have to worry about financing our annual show and can devote our full attention to the show itself. Our Club greatly benefits from having our Foundation.

The Foundation always needs and welcomes your donations and memorial gifts. It is both exempt from federal income taxation, as a 501(c)(3) organization, and qualified to receive charitable contributions and bequests which are tax deductible for federal income, estate, and gift tax purposes.

ANNUAL REPORT FOR 2012 Pensacola Camellia Club Foundation, Inc.

The Pensacola Camellia Club Foundation is a Florida not-for-profit corporation registered with the Internal Revenue Service (ID No. 03-0384090). The Foundation's primary purpose is to help support the Pensacola Camellia Club, its annual Camellia Show, and its other activities. It has received a determination letter from the Internal Revenue Service in which it is recognized as:

- (a) Exempt from federal income taxation under Section 501(a) of the Internal Revenue Code because it qualifies as a 501(c)(3) organization;
- (b) Qualified to receive charitable contributions and bequests which are deductible for federal income, estate, and gift tax purposes; and
- (c) Not required to file an annual income tax return (Form 990) as long as its annual gross receipts do not exceed \$25,000.

In addition, the Foundation has a Sales and Use Tax Exemption from the Florida Department of Revenue (No. 85-8012510865C-5), valid through 12/31/2017, which allows tax-exempt purchases in the State of Florida.

The funds held in the Foundation are the result of the generosity and foresight of our Club's members and friends.

During 2012, the Foundation received income as interest and dividends totalling \$2.081.90.

The amount of the donations (excluding those for the UWF Camellia Garden) received during 2012 was \$130.00.

The Foundation's investment assets as of December 31, 2011, totaled \$49,618.34. It's investment assets as of December 31, 2012, totaled \$56,364.74, an increase of \$6,746.40. Of this, \$1,185.00 is designated for the UWF Camellia Garden. The Foundation also holds title to the red 1995 Chevrolet pickup truck used by the club and donated by Ole Olsen, and the lease for the Club's shade house.
